5) Principal's Report - Ms. Carriere

- There was an engagement night on K-12 Reporting. There was a problem with the password for the Zoom link. There will be more information to come. At KRSS we will see different reporting for gr8&9 with a proficiency scale. Grade 10-12 reporting will be the same with letter grades. Student self assessment will increase

- Recognition of student achievement is on the horizon.

- Laury will be meeting with the district coordinator for the feeding futures funding. She will contact the PAC with information.

- Part of the Feeding Futures Funding includes capital investments for equipment and spaces for food preparation. There will be proposals on a new space in the concession area.

- The athletics department would like to add another cabinet by the gym. It will cost about \$2000. PAC will be given a funding request for the next meeting.

- Student enrollment projections in the spring were for about 520 students. Actual numbers are coming in around 540-550. Most classes are looking good for class sizes. There are a few classes that are higher.

There are 7 new teachers on staff. There are also 3 postings for other positions.
 The funding model from the district for outdoor programming has changed. In the past the Yeti Program was funded at \$1000/full time student enrollment. This year a set program amount has been funded at \$15,000.00. There is no teacher hired for a Yeti this year. It will be run as an afterschool program with Mr. Jason Fisher as a volunteer. There

will no longer be credits attached. More details to come and there is already a trip planned.

- Parent member asked how the school is responding in light of recent events involving school security. Laury says the school is working on the culture and would like to see students have a trusted adult that they can go to in the school. The new home room block is part of this relationship building. Parent member asked if students are aware of the supports available to them. Laury will be sending out a letter to families outlining supports available in school and in the community.
